**FORENSIC EXPERIENCE:**

I have experience testifying before the Board of Industrial Insurance Appeals regarding injured worker cases on behalf of both the injured worker and/or the Department of Labor and Industries (represented by the Washington State Attorney General's Office). In addition, I have testified in crime victims' cases, including shootings, assaults, rapes, stabbings, and child abuse, etc. I have provided medical testimony for the Office of Disability Determination Services and the administrative law judges hearing those cases, regarding claimants who have applied for Social Security assistance due to medical impairment. I have provided competency and capacity evaluations for the Benton County Juvenile Court regarding juvenile offenders whose charges included assault, child molestation, arson, burglary, and criminal trespass, etc. I have provided testimony for numerous private law firms in Washington state for many different types of cases. These include personal injury, automobile accidents, divorce/custody, and workplace issues. I have also evaluated individuals needing security clearances for the federal government, made fitness for duty assessment for Peace Corps applicants, and evaluations for veterans from World War II, Vietnam, Desert Storm, and Operation Iraqi Freedom. One evaluation was at the request of the Consulate General of the Netherlands regarding a survivor of a Dutch POW camp in Sumatra, controlled by the Japanese during World War II. My compensation for forensic cases is \$550.00 per hour.
